#### PRIMARY FUNCTION:

The Van Driver/Youth Bus Driver (Class B Commercial) is responsible for providing safe and prompt transportation of children ages 6-17 years old from school to the Boys & Girls Club. A driver may also be required to provide transportation for the children on field trips on occasion.

# **QUALIFICATIONS (Essential Job Responsibilities):**

- Current CDL Class B. (CLASS-B Commercial LICENSED DRIVER with passenger endorsement). Must have 5
  years driving experience (Personal or Professional). Must have DMV Driver record printout dated within
  the past 30 days of application
- 2. Ability to provide supervision
- 3. Must be able to interact appropriately & positively with children ages 6-17 years old
- 4. Must have ability to motivate youth and manage behavioral problems Program Development Implementation
- 5. Provide Mentoring, Leadership and Supervision to assure proper conduct, safety and development of participants in line with our mission
- 6. Responsible for maintaining required licenses and certifications to transport passengers
- 7. Responsible for safety and supervision of children while in the van, in transit and exiting the van
- 8. Responsible for knowing assigned routes, schedules and passenger for each day
- 9. Safe operation of vehicle as per Boy & Girls Club, State and Federal transportation policies. Ensure vehicles are safe, well ventilated and equipment is maintained in good working condition.
- 10. Responsible for ensuring all passengers follow rules regarding safety in vehicles and enforcement of rules
- 11. Responsible for daily maintenance of vehicles, including interior cleanliness, fluid and fuel levels, documented pre-trip operation, and vehicle inspections
- 12. Support Club administration in local drop off/delivery of donations and supplies as needed

### **MINIMUM QUALIFICATIONS:**

- 1. Must carry a valid CDL Class B with passenger endorsement.
- 2. 2 years experience working in related field preferred
- 3. Must have a minimum of 5 years driving experience
- 4. Submit to a fingerprint/background check
- 5. Submit a clean Driving Record from the DMV and COVID vaccination card
- 6. Drug Test and physical required upon offer of employment

### **ADDITIONAL RESPONSIBILITIES:**

- 1. Always practice and lead with kindness , respect and compassion
- 2. Work with staff on special events to carry out programs in all departments.
- 3. Assume other duties as assigned.
- 4. Develop and maintain relationship to increase club visibility within club and community
